President Bradley asked if we have extra money. When all is done, we should have saved \$8,000-\$10,000. With the Live and Learn Grant, we should have \$125,000. We have revenue coming in from the Age Options Grant, and money coming from patron copying and faxing. The Village money is coming in low.

## b) Review Village Financials\*

Director Rayford stated that everything looks to be on target. We have no balance sheets from the Village for both December and January. Members of the board had questions about digital materials from Libby and Hoopla. Does the Library own the items? Director Rayford explained how the purchase of these items work.

Director Rayford went on to say that maybe once the new person is hired we might eliminate the business assistant position. The budget will be tight going forward.
